 Families enrolled in our program are expected to pay in full for partial school week closings during school vacations and or for in-service/snow days. Tuition fees are based on enrollment and not attendance. Therefore, if a child does not attend due to illness, or for any other reason, the full fee is due. We cannot provide free make up days if you miss a regularly scheduled day. We will observe the following paid holidays: MLK day, Memorial Day, July 4th, Labor Day, Thanksgiving and the day after, Christmas and New Year's. We also schedule 4 days per year for in service days for staff development, and for parent/teacher conferences. These are required by the State of Vermont. These days are included in our full weekly tuition fees. Fees are due on the first day of the week that your child attends if you pay weekly, or the first day of the month if you pay monthly. Late payments will be subject to a \$5.00 late charge if late more than 2 days. If you are receiving childcare subsidy from the Child Care Financial Assistance Program, you are responsible for maintaining a valid subsidy certificate and for paying applicable co-payments on time. If your certificate should lapse, you will become responsible for making full tuition payments on time. Annette's reserves the right to terminate this contract with a 24 hour notice should it be determined that commitments and responsibilities are not being met by the parent/guardian. Termination may also occur if 					
 the provider deems for any reason that continuation of care is not in the best interest of Annette's Preschool. Non-payment of tuition when due may be cause for termination. There is a late pick up fee of \$5.00 for every 5 minutes you are late after our closing time of 5:30 PM.
